#### Deadlines to be observed:

- 1st closing date: August 13<sup>th</sup> 2019, 2nd (and final) closing date: September 13<sup>th</sup> 2019.

- Deadline for catalogue ads: August 31<sup>th</sup> 2019.
- Reservation of guesthouse must be received no later than July 31<sup>th</sup> 2019.
- The password for accommodation booking: SAMOYED

#### Payments:

- All payments must be made to closing dates via our bank.
  - All fees must be paid in full in order to publish dogs in the catalogue, and confirm reservations for hotel, seminar, and recreational activities.
  - Please send your payment to our bank account. Cheques are not accepted.

  - Full payment must be received no later than 1 week from filling in the entry form.

#### Show Regulations:

- Photocopy of the pedigree including owner data filled in must be enclosed.
- If entered in Winner class, documentation for national or international championship, national winner title, club winner title, specialty winner title and World or European winner title must be enclosed.
- Dogs born in the Czech Republic must have a valid inoculation certificate (pursuant to Section 6, Veterinary Act) or a valid passport for small animals.
- Dogs from EU member states and Third World countries must meet the conditions given by regulations of the European Parliament and Council of Europe 998/2003 of 26.5.2003.
- Documentation for vaccination must be brought to the show.
- Puppies under the age of 4 months must not be brought to the show.
- Shown dogs must be in good mental and physical health condition and not show any signs of illness.

#### Important Information:

All owned dogs must be registered in an organisation recognised by the FCI.

With his signature on the entry form, the exhibitor certifies:

- that he is acquainted with the CMKU and FCI show regulations.
- that he will observe these regulations.
- that the dog is shown at his own expense and risk.
- that he is not a member of a cynological organisation, which is not recognised by the FCI.
- that he is responsible for the correctness of the data stated on this entry form.
- that he agree with the publication of his name and address in the show catalogue.
